

Terms& Conditions of Agreement-IEX Import

- 1. The tariff is applicable for your import shipments.
- 2. All the rates are in Rs. (Rupees).
- 3. The tariff is for General courier/cargo shipments only. DG (Dangerous Goods) shipments will be handled separately.
- 4. Goods and Services Tax will be charged on the existing tariffas per the Government Regulation.
- 5. Fuel surcharge @ 17% will be charged on the existing tariff.
- 6. Bills will be presented in the first week on every month.
- 7. Interest @ 21% per annum will be charged on bills which not settled within 30 days of bill submission.
- 8. The minimum chargeable weight under Cargo mode will be 25 kg.
- 9. There will be additional clearance charges of Rs.2,500/- under below circumstances.
 - a) If shipment imports in Cargo mode
 - b) If shipment falls under high value clearance (CIF value exceeds Rs.100,000/-)
- 10. D.O. Charges will be charged additionally. (as per receipt)
- 11. Warehouse/Storage charges will be charged additionally.(as per receipt)
- 12. Switching invoice charge will be Rs.1,000/- per invoice.
- 13. Import Custom Duty and Tax will be charged additionally. (as per receipt)
- 14. Any special packing/handling charges will be charged additionally.
- 15. There will be additional charges for the goods requiring specific conditions to be fulfilled under any Act other than the customs Act or any Rules & Regulations framed under such Act.
- 16. Custom Processing Charges (CPC) will be processed under as follows;
 - a) In case Customs duty paid by OCS,

5% of (Custom Duty +D.O. Charges + Storage Charges + Any other actual cost)
Or minimum Rs.500/-

b) In case Customs duty paid by client directly,

A minimum charge of Rs.1,000/-



17. Chargeable weight will be actual or volumetric, whichever is higher. Volumetric weight will be calculated as =

Length x Width x Height (in cm)/5,000

- 18. The client shall be responsible for the insurance of the consignment. (if requires)
- 19. Consignee will be responsible for any fine/penalty occurred at the customs due to non-availability of any desired documents which needs to be filed in the BOE (Bill of Entry) at respective customs office.
- 20. Your account will henceforth be automatically renewed year after year under the same terms & conditions unless otherwise amended or terminated in writing by either of us.
- 21. Any changes in the tariff due to unforeseen contingencies will be intimated prior to its implementation.
